Venue:	Pat Morley Oval (Cresthaven Avenue, Bateau Bay NSW 2261)	
Transport:	Private vehicle. Parents are responsible for transporting their child to and from the venue. Children are to be accompanied by an adult to and from the venue. Please contact Mr Foyel or Mrs Herring if you are unable to do this.	
Dress Code:	Soccer jerseys will be provided. Students will need to wear shorts and socks similar to the colour of the school uniform (Black shorts/socks are okay). They will need to bring a school hat, shin pads and soccer/football boots. Boots mus not be longer than 21mm and must not have any ridges, burring or sharp edges. Goal keepers will need to bring their goalie gloves.

Food:	Students will need to bring a water bottle, sunscreen, recess and lunch on the day. Please pack food and water for the whole day. There will be no canteen at the ground.
