Health Care Needs							
When a medical practitioner has prescribed medication (including emergency medication) that will need to be administered during the event, parents are responsible for: • bringing this need to the attention of the school, including completing a written request to administer medication (forms are available on the school website); • ensuring that the information is updated if it changes; • supplying the medication and any 'consumables' necessary for its administration in a timely way; • ensuring the medication is well within its expiry date; and • collaborating with the school in working out arrangement for the supply and administration of the prescribed medication for the duration of the event. For some events, the school will ask parents to supply the medication in a different way to what has already been agreed by the school. For example, parents may be asked to supply an additional adrenaline autoinjector (i.e. EpiPen® /Anapen®). For asthma and anaphylaxis it is important for students to have immediate access to their medication. Please consider whether your child should carry their own EpiPen®, Anapen® or asthma reliever medication while at school.
